## **Information on Organizational Affiliate Status North Carolina Nurses Association**

AN ORGANIZATIONAL AFFILIATE OF NCNA IS AN ASSOCIATION THAT:

- a. Is a nursing organization that meets criteria established by the NCNA Board of Directors, and
- b. Has been granted organizational affiliate status by the Board of Directors, and
- c. Has a governing body composed of a majority of registered nurses, which is not meant to preclude the participation of associate nurse organizations, and
- d. Has paid an organizational affiliation fee to NCNA in accordance with policies established by the NCNA Board of Directors.

ORGANIZATIONAL AFFILIATE OBLIGATIONS:

Each organizational affiliate shall maintain a mission and purpose harmonious with the purposes and functions of NCNA.

ORGANIZATIONAL AFFILIATE RIGHTS:

The organizational affiliate shall have the right to:

- a. Designate one registered nurse participant in the NCNA Membership Forum.
- b. Make informational reports in their area of expertise to the NCNA Membership Forum.
- c. Recommend positions to the NCNA Membership Forum.
- d. Submit for consideration by the NCNA Board of Directors names of registered nurses who are qualified for appointment to NCNA organizational units.
- e. Submit educational offerings for the NCNA annual convention.

## Organizational Affiliate Services

NCNA offers the following services to Organizational Affiliates and their members:

- ! A subscription to NCNA's newsletter, the **Tar Heel Nurse**, will be provided to the Organizational Affiliate President and Executive Director.
- ! A subscription to the electronic newsletter, Inside NCNA, will be provided to the Organizational Affiliate President and Executive Director.
- ! Individual members of Organizational Affiliates will enjoy a 10% discount on the **Tar Heel Nurse** subscription price.
- ! Organizational Affiliates will be recognized annually in the **Tar Heel Nurse**.
- ! Organizational Affiliates will have the opportunity to submit one organization-specific news brief for publication in the **Tar Heel Nurse**. This information will be included in the News Briefs column (NCNA retains editorial privilege).
- ! Organizational Affiliates are able to post a logo and officer information on the NCNA Organizational Affiliates webpage.
- ! Organizational Affiliates will receive, by email, the Legislative Update posted on the NCNA web site biweekly during sessions of the North Carolina General Assembly which highlights legislative news of interest to nurses.
- ! One official representative from each Organizational Affiliate will be invited to the annual NCNA convention at the NCNA member rate. It is expected that a reciprocal invitation will be extended to a NCNA representative for the Organizational Affiliate's annual meeting.
- ! Organizational Affiliates will enjoy a special 20% discount on the continuing education approval process for their statewide annual meetings and a special 10% discount on any other meeting held throughout the year.
- ! Organizational Affiliates will enjoy a special 25% discount off the usual exhibitor fee for NCNA conventions. It is expected that a reciprocal agreement will be extended to NCNA for exhibits at the Organizational Affiliate's annual meeting.
- ! Organizational Affiliates will enjoy a 10% discount on advertising in any of NCNA's publications pending space availability.
- ! Organizational Affiliate individual members will receive a discount on registration fees for the NCNA annual convention.
